

County Commissioners Special Meeting  
March 29, 2021

Lee Doolen called the meeting to order at 9:03 A.M. Members Carl Munson and Marlon Miller were also present.

Flag Salute was led by Lee Doolen and prayer was led by Don Sporleder.

Miller made a motion to approve the minutes from the March 22, 2021 Public Hearing and Commissioner meeting. Motion seconded by Munson. Doolen, Munson and Miller all voted aye.

Item #7: Munson made a motion to approve a contract between the County Health department and Falco Alarm Systems. Motion seconded by Miller. Doolen, Munson and Miller all voted aye.

Item # 5: Discussion was held amongst the Commissioners, City Managers, Sheriff's Department and EMS Representatives in regards to a proposed special election for the vote of a Public Safety Sales Tax that would address new jail construction and enhanced ambulance services. City Managers voiced their concern with implementing a new sales tax and feel that the two items should be separate on a ballot. Representatives from Ambulance Districts expressed interest in forming a 522 Ambulance District. Commissioner Miller presented the idea to put a special fee for ambulance service on car tags. This idea would have to go through the Legislative process, but Miller was encouraged to pursue this concept.

Sheriff Dougherty explained that the construction of a new jail is long overdue. The existing building will not hold up another 20 years. The time to address this issue is now. Commissioner Doolen encouraged those present to tour the jail. The Commissioners will continue discussion at the April 5<sup>th</sup> meeting to determine funding plans for both projects.

Item #6: No action was taken to approve a special election at this time.

Munson made a motion to approve claims. Motion seconded by Miller. Doolen, Munson and Miller all voted aye.




