MINUTES OF THE LINCOLN COUNTY ELECTION BOARD MEETING MARCH 5, 2024

The Lincoln County Election Board met in a regular meeting at 4:00 p.m. at the Election Board Office, Suite 15, Lincoln County Courthouse, 811 Manvel Ave., Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 1, 2023, at 9:40 a.m. and by posting an agenda at the County Election Board office on February 27, 2024, at 3:05 p.m. One copy of the notice and one of the agenda is attached.

The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.
BUSINESS CONDUCTED AT THE MEETING

1. CALL TO ORDER by Marak at 4:00 p.m.
2. ROLL CALL by Stambaugh: Perna, aye; Marak, aye; Stambaugh, aye; All members present.
3. BUSINESS CONDUCTED: Discussion and approval of minutes of the March 2, 2024, special meeting. Motion by Perna, second by Stambaugh, minutes be approved. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
4. BUSINESS CONDUCTED: Process absentee ballots for the March 5, 2024, Presidential Preferential Primary Election. After opening the outer envelopes and examining the affidavits, the Board determined that a total of 13 absentee ballots were sufficient to count. No ballots were rejected. ACTION TAKEN: Motion by Perna, 2nd by Stambaugh to count 13 ballots. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
5. BUSINESS CONDUCTED: Recess Meeting, if needed. ACTION TAKEN: Motion by Stambaugh, 2nd by Perna to recess meeting at 4:48 p.m. and reconvene at 6:30 p.m. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0. The meeting was reconvened to 6:30 p.m.
6. BUSINESS CONDUCTED: Canvass returns. Board members were present and participated in the receipt of voting devices, election supplies and transfer boxes with ballots from inspectors; the tabulation of election results and production of tabulation reports and summary results reports; and the transfer of transfer boxes to the sheriff for security were placed in the secure vault. Canvassing of the Presidential Preferential Primary March 5, 2024, Election Returns were reviewed by the board. ACTION TAKEN: None. Board action not required.
7. BUSINESS CONDUCTED: Adjourn Meeting. ACTION TAKEN: Perna motioned to adjourn the meeting, 2nd by Stambaugh. Perna, aye; Marak, aye; Stambaugh, aye. Motion passed. 3-0. The meeting was adjourned at 8:29 p.m.
