### OF THE LINCOLN COUNTY ELECTION BOARD MEETING

SEPTEMBER 12, 2023

The Lincoln County Election Board met in a special meeting at 6:00 p.m. at the Election Board Office, Lincoln County Courthouse, Ste. 15, Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on June 14, 2023, at 12:32 p.m. and by posting an agenda at the County Election Board office on September 5, 2023, at 10:00 a.m. One copy of the notice and one of the agenda is attached.


The following members were present: James Marak, Anthony Perna, Melissa Stambaugh.

### BUSINESS CONDUCTED AT THE MEETING

1. The meeting was called to order at 6:00 p.m. Roll Call taken; members present listed above.
2. **BUSINESS CONDUCTED:** Discussion and approval of minutes of the August 11, 2023, special meeting. **ACTION TAKEN:** Motion by Perna, second by Stambaugh, minutes be approved. **ROLL CALL VOTE:** Perna, aye; Marak, aye; Stambaugh, aye. Motion passed 3-0.
3. **BUSINESS CONDUCTED:** Process mail and nursing home absentee ballots submitted for the September 12, 2023, election. After opening and examining the absentee ballot, we found that the 1 affidavit was sufficient to count. Motion by Marak, second by Perna to accept the 1 ballot. No affidavits were rejected. **ROLL CALL VOTE:** Perna, aye; Kinnear, aye; Stambaugh, aye. Motion passed 3-0.
4. No recess necessary.
5. Board members were present and participated in the receipt of voting devices, election supplies and ballots from inspectors, the tabulation of election results and production of tabulation reports and summary results reports.
