The Lincoln County Election Board met in a regular meeting at 4:00 p.m. at the Election Board Office, Lincoln County Courthouse, Ste. 15, Chandler, Oklahoma. Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 1, 2022, at 9:00 a.m. and by posting an agenda at the County Election Board office on February 8, 2023, at 8:45 a.m. One copy of the notice and one of the agenda is attached.

The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.

### BUSINESS CONDUCTED AT THE MEETING

- 1. Meeting was called to order at 4:05 p.m. Roll Call taken; all members present.
