Advance public notice of the meeting was performed by filing a written notice with the County Clerk on December 1, 2022, at 9:00 a.m. and by posting an agenda at the County Election Board office on February 21, 2023, at 12:30 a.m. One copy of the notice and one of the agenda is attached.

The following members were present: Anthony Perna, James Marak, Melissa Stambaugh.
